- Memastikan tiada penggunaan *Paraquat*, racun makhluk perosak yang dikategorikan d bawah Kalas 1A atau 1B Pertubuhan Kesihatan Sedunia, kimia disenaraikan di bawah Konvensyen Stockholm dan Rotterdam.
